



Expression of Interest for Purchase of 3000 MW Solar Power

Introduction:

Solar Energy Corporation of India Limited (SECI) a CPSU under the aegis of Ministry of New and Renewable Energy (**MNRE**) has been instrumental in proliferation of Solar Power as an alternate & renewable energy source and has aligned itself with Govt. policies towards rapid acceleration of solar power generation capacity through compliance to solar RPO requirements. Present rate of RPO (Renewable Power Obligation) is envisaged to be enhanced with a target to achieve Solar Power of 3% total power by 2022, which again is likely to be increased substantially to boost up green and reliable energy availability. SECI in line with the national objectives has now embarked on a plan to make available 3000 MW Solar Power in coming three (3) years i.e. by 2017-18.

Objective:

SECI thus invites Expression of Interest from environmentally conscious, concerned and prospective bulk buyers / utilities / Industrial Organisations and consumers/ other obligated entities, interested in expansion of green power portfolio by purchasing Solar Power of their requirement, in total aggregating 3000 MW in three (3) years i.e. by 2017-18.

Scope: These buyers / consumers will enter into power purchase agreements with SECI or their Project developers on long term agreement basis for 25 years to meet their obligations for purchase of solar power or other requirements.

Supply Schedule: SECI plans to enhance supplies by 1000 MW capacity approximately per year against this EOI for envisaged aggregate supply of 3000 MW in 3 years i.e. by 2017-18.

Target Beneficiaries:

State Utilities & Discoms trying to augment and meet RPO obligations, Large Industrial and Commercial Organisations with bulk power requirement trying to reduce carbon footprints, Power Trading organisations interested in enhancing their green power portfolio, amongst others.

Time Period:

Total time period envisaged for aggregate capacity of 3000 MW is thirty six (**36**) months with phased delivery of aggregate 1000 MW every twelve (12) months.

- 1) Interested parties are required to submit information complete in all respects in the enclosed format (Refer **Annexure-A**).
- 2) Prospective parties may submit their 'Expression of Interest' along with relevant details as sought in the data sheets latest by **17th June 2015**, in two (2) hard copies (**1 Original + 1 Photocopy**) in a sealed cover super scribing "**Expression of Interest (EOI) for Purchase of 3000 MW Solar Power in 3 years**".
