- 3. The appointment of IEMs shall be governed by the following terms and conditions:

 - ii. **TENURE**: For a period of three (03) years w.e.f. the date of issue of this order.
 - OTHER ITEMS: As per para 4.10 of the guidelines issued by the CVC vide iii. circular no. 02/01/2017 dated 13.01.2017, the Department may provide assistance to IEMs.
 - iv. PLACE OF SITTING: New Delhi.
- The IEMs are requested to sign and return the copy of Non-disclosure Agreement and declaration of absence of conflict of interest undertaking (copy attached) within 15 days.
- Accordingly, all the concerned officers are requested to take the following actions immediately:
 - i. All RfS/ Tenders where the estimated cost exceeds Rs Hundred Crore (100 crores), the name of the IEMs may be suitably incorporated.
