India—ISA Energy Transition Dialogue 2021 being organized by the International Solar Alliance and Ministry of New and Renewable Energy, Govt. of India to facilitate the exchange of ideas between key RE stakeholders on core issues like grid integration to facilitate high renewable energy penetration, frameworks for accelerating RE, and will also enable sharing India story with ISA member countries.

The dialogue is likely to be inaugurated by Hon'ble Minister of Power and New and Renewable Energy, Government of India and President of COP 26. Policy Makers, National Focal Points of ISA member states, Energy Ministries, other Ministries, or Departments involved in scaling-up solar in member countries, Power distribution companies / utilities, Private sector, Chambers of commerce in Member countries, Investment Promotion Agencies, MDBs, DFIs, UN bodies, think tanks, academia, R&D organizations will be attending the dialogue on a virtual medium.

The key objective of 'India ISA Energy Transition Dialogue' is to facilitate informed policy interventions and decision making for the energy transition world over by discussing success stories from India through an interactive and structured dialogue; to position One Sun One World One Grid initiative by GOI, ISA & World Bank as a key accelerator for the energy transition; to enable member countries to re look at their national strategies for energy transition and to augment and strengthen the efforts being made towards high-level dialogues like UN-HLD on Energy Transition and COP-26. This dialogue will also bring focus on challenges that developing nations are facing in the path to the transition from fossil fuels to renewables.
