Solar Plant Technology using Photovoltaic Cell falls under "White Category" which is considered as a non-polluting categories of industries. With reference to the copy of the press release on 05th March, 2016 by Hon'ble Environmental Minister Prakash Javadekar, Ministry of Environmental and Forest, it's been stated that category of white industries will not require environmental clearance and consent" (The copy of the same is annexed). Further, the resettlement and rehabilitation will be as per the Right to Fair Compensation and Transparency in Land Acquisition, Rehabilitation and Resettlement Act, 2013 which is also not under the purview of MOEF. Undertaking the ESIA as per the World Bank guidelines will need experience in comprehending World bank Operational policies. PwC has undertaken numerous studies for solar plants and solar parks in line with the World Bank guidelines (which included the environmental and social impact assessments). Thus we would humbly request SECI to consider excluding the eligibility criteria "MoEF accrediated EIA consultant" to ensure optimum participation.
